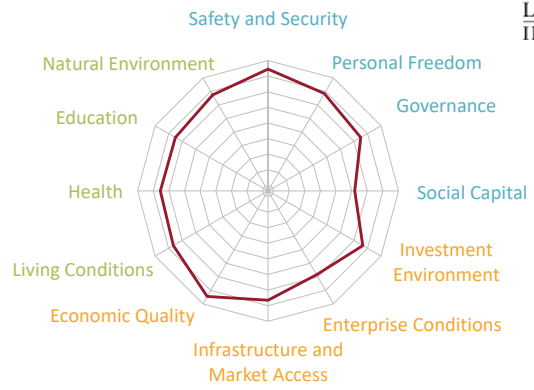
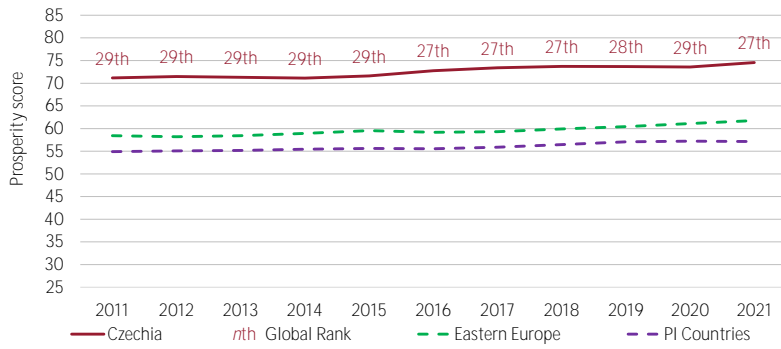




Czechia: Prosperity score 74.6 (27th)
